Installation 2

Use the following steps to install the HDD unit in the PL.

Since the HDD unit is a precision instrument that has a low resistance to shocks, be sure it is neither hit by nor pressed strongly against another object when installing it.



1) Unscrew the expansion slot's two (2) blank panel screws, and remove the blank panel.

- 2)Hold the HDD unit's removal handle and slide the unit slowly into the expansion slot, until the rear face connector is completely inserted into the slot's connector pins.
- 3) Reattach the two (2) expansion slot cover attachment screws.



Note: When installing an HDD unit 🖄 in other Expansion Slots, use the above installation procedures.

3 Hardware Setup

The HDD unit's installation and system data settings are as follows.

- 1) Install the HDD unit in the PL. Refer to *2 Installation* for details. If the HDD unit is already installed, this step is not necessary.
- 2) Connect a keyboard to the PL.
- **3**) Turn on the PL unit's power supply and use the following steps to set up the system data and recognize the HDD unit.



- Normally, use the factory (initial) settings.
- Your PL unit's system data screen menus may differ slightly from these due to installation of newer software.
- The following explanation uses the PL unit's factory settings.
- 4) When the "Press to enter SETUP" message appears, press your PC's DEL key.

The Setup utility will start. Select the [Standard CMOS Features] and the following screen will appear.

- 5) Confirm whether "AUTO" is selected in the Master screens. If AUTO is selected in both, disk parameters will be automatically read when the PL is turned ON. If AUTO is not selected, change these settings to AUTO. The factory setting is AUTO and recommended for most users. (When using together with HDD unit.)
- 6) After changing all settings, press the ESC key and select [Save & EXIT Setup] to save the settings. The OS will then start.

■ Windows[®] 2000 Setup Procedure

Note: A detailed explanation of the software, as well as a list of the revisions made after the printing of this document can be found in the HDD unit and the Recovery CD-ROM's README.txt files.

- 1) Once the PS-B unit's power is turned ON, this HDD unit's [Windows 2000 Professional Setup] screen, and then the [Welcome to the Windows 2000 Setup Wizard] will appear. Click on [Next].
- 2) The [License Agreement] screen will appear. After reading the contents press [] accept this agreement] if x

After reading the contents, press [I accept this agreement] if you agree, and click [Next] to continue.

- 3) The [Regional Settings] screen will appear. After entering the data for your area, click [Next] to continue.
- 4) The [Personalize Your Software] screen will appear After entering your name [Name] and [Organization], click on [Next] to continue.
- 5) The [Your Product Key] screen will appear.

After entering the product key data, click on [Next] to continue.

6) The [Computer Name and Administrator Password] screen will appear. Enter the [Computer Name and Administrator Password], and [Confirm Password], then click [Next] to continue. When entering the [Computer Name], if the name shown on the display is not correct, you can enter another name. When the computer is connected

to a network, be sure to ask your network manager what is the correct name for this field.

7) The [Date and Time Settings] screen will appear.

After entering these settings, select [Next] to continue.

8) [Network Settings] screen will appear.

Choose whether to use typical or custom settings depending on your PC circumstantce.

9) [Workgroup or Computer Domain] screen will appear.

Choose wheter to make your PC on a network or not depending on your PC circumstance.

10)[Performing Final Tasks] is automatically done by the PS-B. The [Completing the Windows 2000 Setup Wizard] will appear. Press [Finish] and the system will automatically restart.

- 11) When the [Network Identification Wizard] screen and the [Welcom to the Network Identification Wizard] is started, please press [Next]. The [Users of This Computer] screen will appear. After entering the desired settings, press [Next] and then press the [Finish] button.
- 12) The [Selection of a Display] screen will appear.

Select the PL Series name you are using and the diplay size will be adjusted.

The sysytem will automatically restart, now you can use the Windows[®] 2000.

HDD Recovery Procedure

- After performing hard disk recovery, the PL unit's hard disk is returned to its factory shipped condition.
- A USB-type CD-ROM drive cannot be used to start the Recovery CD. Be sure to use Digital's CD-ROM drive unit (PL-DK200/PSS-CD01).

Use the following steps used to recover the Windows[®] 2000 Multi-Language Preinstalled Hard Disk.

- 1. Insert the Recovery CD's Disk 1 into the CD-ROM drive and turn the PL unit's power ON. Immediately after the power turns ON, keep pressing the [Del] key. The unit's BIOS setup screen will appear.
- 2. Select [CDROM] for [First Boot Device] of [Advanced BIOS Features].

- 3. Press the [F10] key to save the setting and restart the PL unit.
- 4. After the PL unit restarts, the Symantec Ghost[™] will automatically start.
- 5. After the Symantec Ghost[™] starts, the [Question] dialog box will appear. "Partition sizes correct?"
- 6. The volume displayed in New Size will be recovered. After confirming it, press the [Yes] button. To change it, press the [No] button and go to the [Destination Drive Details] dialog box. In the [Destination Drive Details] dialog box, change the size of the New Size and press the [OK] button.
- 7. The [Question] dialog box will appear. Press the [Yes] button. It will be reconfirmed that the data of the hard disk is all reset to the original values at the time of delivery.

"Proceed with disk restore?

Destination drive will be permanently overwritten."

- 8. The Recovery CD's Disk 1's hard disk recovery program will start. After a while, the [Span Volume [1] Done] dialog box will appear. Replace the Recovery CD's Disk 1 in the CD-ROM drive with the Recovery CD Disk 2 and press the [OK] button. Follow the same step for the Recovery CD Disk 3 and press the [OK] button.
- 9. After the recovery operation finishes, Symantec GhostTM finishes and the following message will appear. After the message appears, turn off the power supply of the unit.

"Please turn off the computer."

- 10. After turning on the power supply once again, push the [DEL] key to go to the BIOS Setup Screen.
- 11. In the Setup screen, set Load Optimized Defaults to reset all BIOS settings to their original values at the time of delivery. When using FD, set [1.44M, 3.5 in] for [Drive A] of [Standard CMOS Features]. Press the [F10] key to save the settings and restart the unit.
- 12. After the unit restarts, set up your OS. \checkmark Reference $\checkmark 4 \text{ OS Setup}$



- If the hard disk unit breaks down due to a hardware problem, (Ex. if BIOS cannot find the hard disk, if the hard disk's lifetime expires, or it breaks down), Symantec Ghost[™] cannot recover the hard disk. Pro-face recommends that in this case you contact your local PL distributor for instructions about hard disk recovery or replacement.
- Pro-face does not guarantee the preservation of any data stored on the HDD unit if the HDD unit has an accident, malfunctions or is damaged in any way. Therefore, the regular backing up of important HDD unit data to either floppy disks, or other type of suitable magnetic media is strongly recommended.

7 When using PL-B920 Series Unit

The connection method used can be via either a serial or USB interface. Also, the type of OS and Touch Panel Device Driver (mouse emulator) used will depend on the type of connection method used for the display and for the touch panel.
