
Use the following steps to install the HDD unit in the PS-B.




Since the HDD unit is a precision instrument that has a low resistance to shocks, be sure it is neither hit by nor pressed strongly against another object when installing it.




- 1) Lay the PS-B unit on its side and unscrew the four (4) cover attachment screws.
- 2) Slide the cover horizontally in the direction shown by the arrow (see diagram) and lift it out from the PS-B unit. (Go to step 3.)



You can also remove only the maintenance cover and install the HDD unit. To do this, please perform the following steps.





1) Loosen the two (2) maintenance cover attachment screws.



2) Tilt the maintenance cover up as shown by arrow (a) and lift it out in the direction shown by arrow (b) (see diagram).



3) Insert the HDD unit's cable connector completely into IDE I/F 1.



- 4) Attach the HDD unit using the four (4) attachment screws. (See diagram) The torque should be 0.5 to 0.6 N·m.
- 5) Replace the PS-B unit's cover and reattach all four (4) attachment screws. The torque should be 0.6 to 0.8 N·m. If you used the maintenance cover, replace that cover and fasten the its two (2) attachment screws. The torque should be 0.5 to 0.6 N·m.

3 Hardware Setup

The HDD unit's installation and system data settings are as follows.

- 1) Install the HDD unit in the PS-B. Refer to *2 Installation* for details. If the HDD unit is already installed, this step is not necessary.
- 2) Connect a Display and PS/2 keyboard to the PS-B.



- Use a display with SVGA (800 x 600) or more resolution and 16 bit color or more.
- 3) Turn on the PS-B unit's power supply and use the following steps to set up the system data and recognize the HDD unit.



- Normally, use the factory (initial) settings.
- Your PS-B unit's system data screen menus may differ slightly from these due to installation of newer software.
- The following explanation uses the PS-B unit's factory settings.
- **4)** When the start-up screen appears, press your PC's [F2] key to go to the BIOS Setup Screen. In the Setup Screen, select [Standard CMOS Features], then select [IDE Primary Master]. The following screen will appear.

- 5) Confirm whether "AUTO" is selected for IDE Primary Master. Also, confirm whether "AUTO" is selected for the [Access Mode]. If AUTO is not selected, change these settings to AUTO with the + or key. If AUTO is selected in both, disk parameters will be automatically read when the PS-B is turned ON. The factory setting is AUTO and recommended for most users.
- **6)** After all changes are made, press the ESC key and select [Save & EXIT Setup] to save the settings. The OS will then start.

■ Windows® XP Setup Procedure

The Windows® XP Setup Procedure will be described below. The setting items differ depending on a user's environment. Please check with your network manager and make correct settings.



A detailed explanation of the software included, as well as a list of the revisions made after the printing of this document can be found in the HDD unit's README.txt file. Be sure to see it before work.

- 1) Once the power of the PS-B unit with Windows® XP preinstalled is turned ON, the [Welcome to Microsoft Windows] screen will appear. Click on [Next].
- 2) The [The End User License Agreement] screen will appear.

 After reading the contents, press [Yes, I accept] if you agree, and click [Next] to continue.
- 3) The [Help protect your PC] screen will appear. Choose whether to update Windows® automatically. To enable the Automatic Updates, check on [Help protect my PC by turning on Automatic Updates now (recommended)]. To disable it, check [Not right now]. Click [Next] to continue.
- 4) The [What's your computer's name?] screen will appear.

 After entering the computer's name, click [Next] to continue. At default, the computer's name has been entered. If it's not necessary to change it, click [Skip].
- 5) The [What's your Administrator password?] screen will appear. If the password is set, enter the password in [Administrator password:] and [Confirm password:] and click [Next]. If the password is not set, click [Skip].
- 6) The [Is this computer in a domain?] screen will appear. To join the domain, select [Yes, make this computer a member of the following domain:] and enter the domain's name. Not to join the domain, click [Next] to continue.
- 7) The [Checking your internet connectivity?] screen will appear and your internet connectivity will be automatically checked.

- 8) The [Ready to register with Microsoft?] screen will appear.

 If you register, check [Yes, I'd like to register with Microsoft now].

 If not, check [No, not at this time]. Press [Next].
- 9) The [Who will use this computer?] will appear. Up to 5 names can be entered for a user's name. After entering the user's name, click [Next] to continue.
- 10) The [Thank you!] screen will appear. Click [Finish] to complete the setting.



As for how to change BIOS Setting, refer to the PS-2000B Series User Manual. After changing the BIOS, restart the Windows® and make the setting following the instructions shown on the screen.

- Designating the Language
- 1) Select the Windows® XP [Start] menu's [Control Panel].
- 2) Select [Date, Time, Language, and Regional Options] in the Control Panel and then the [Regional and Language Options] command.
- 3) Select the appropriate language from "Language used in menus and dialogs" in the [Languages] tab.

HDD Recovery Procedure



- After performing hard disk recovery, the PS-B unit's hard disk is returned to its factory shipped condition.
- For recovery, the following things are required;
 The PS-B unit, HDD to be recovered, a CD-ROM drive (PSB-CD/FD01 or a commercial USB-type CD-ROM drive), and a PS/2 keyboard.

Use the following steps used to recover the Windows® XP Multi-Language Preinstalled Hard Disk.

- 1. Insert the Recovery CD's Disk 1 into the CD-ROM drive and turn the PS-B unit's power ON. Immediately after the power turns ON, keep pressing the [F2] key. The unit's BIOS Setup Screen will appear.
- Select [CDROM] for [First Boot Device] of [Advanced BIOS Features].
 (When using a commercial USB-type CD-ROM drive, select [USB-CDROM] for [First Boot Device].)
- 3. Press the [F10] key to save the setting and restart the PS-B unit.
- 4. After the PS-B unit restarts, the Symantec Ghost TM will automatically start.
- 5. After the Symantec Ghost starts, the [Question] dialog box will appear. "Partition sizes correct?"
- 6. The volume displayed in New Size will be recovered. After confirming it, press the [Yes] button. To change it, press the [No] button and go to the [Destination Drive Details] dialog box. In the [Destination Drive Details] dialog box, change the size of the New Size and press the [OK] button.
- 7. The [Question] dialog box will appear. Press the [Yes] button. It will be reconfirmed that the data of the hard disk is all reset to the original values at the time of delivery.
 - "Proceed with disk restore?

 Destination drive will be permanently overwritten."
- 8. The Recovery CD's Disk 1's hard disk recovery program will start. You will be prompted several times. Please replace the Recovery CD Disk each time as instructed.

- 9. After the recovery operation finishes, Symantec Ghost TM finishes and the following message will appear.
 - After the message appears, turn off the power supply of the unit. "Please turn off the computer."
- 10. After turning on the power supply once again, push the [F2] key to go to the BIOS Setup Screen.
- 11. In the Setup screen, set Load Optimized Defaults to reset all BIOS settings to their original values at the time of delivery. When using FD, set [1.44M, 3.5 in] for [Drive A] of [Standard CMOS Features]. Press the [F10] key to save the settings and restart the unit.
- 12. After the unit restarts, set up your OS.

- If the hard disk unit breaks down due to a hardware problem, (Ex. if BIOS cannot find the hard disk, if the hard disk's lifetime expires, or it breaks down), Symantec Ghost™ cannot recover the hard disk.
